ABOUT THE SEMINAR "Influence of Swami Vivekananda and Gautam Buddha in Culture and Civilization of South East Asia"

Gautama Buddha(c. 563/480 – c. 483/400 BCE), also known as Siddhārtha Gautama (सिद्धार्थ गौतम) in Sanskrit or Siddhāttha Gotama (शिद्धत्थ गोतम) in Pali , Shakyamuni (i.e. "Sage of the Shakyas") Buddha, or simply the Buddha. Gautama is the primary figure in Buddhism. He is believed by Buddhists to be an enlightened teacher who attained full Buddhahood and shared his insights to help sentient beings end rebirth and suffering. Accounts of his life, discourses and monastic rules are believed by Buddhists to have been summarised after his death and memorized by his followers.

Buddhism is thought to have entered Southeast Asia from trade with India, China and Sri Lanka during the 1st, 2nd and 3rd centuries. One of the earliest accounts of Buddhism in Southeast Asia was of a Theravada Buddhist mission sent by the Indian emperor Ashoka to modern-day Burma in 250 BCE. Due to the continuous regional trade between Southeast Asia, China and South Asia, Buddhism spread throughout Southeast Asia. After the initial arrival in modern-day Burma, Buddhism spread throughout mainland Southeast Asia and into the islands of modern-day Malaysia and Indonesia. There are two primary forms of Buddhism found in Southeast Asia, Theravada and Mahayana. Theravada Buddhism spread from India to Sri Lanka then into the region as outlined above, and primarily took hold in the modern states of Burma, Cambodia, Laos, Thailand and southern Vietnam. Mahayana Buddhism is thought to have spread from both China and India during the first and second century into Southeast Asia.

Swami Vivekananda (12 January 1863 – 4 July 1902), born Narendranath Datta, was an Indian Hindu monk, a chief disciple of the 19th-century Indian mystic Ramakrishna. He was a key figure in the introduction of the Indian philosophies of Vedanta and Yoga to the Western world and is credited with raising interfaith awareness, bringing Hinduism to the status of a major world religion during the late 19th century. He was a major force in the revival of Hinduism in India, and contributed to the concept of nationalism in colonial India. Vivekananda founded the Ramakrishna Math and the Ramakrishna Mission.

In September 1893, Swami Vivekananda delivered a series of speeches on 'India and Hinduism' in "the Parliament of the World's Religions" in Chicago. This event also marked the first world conference of the representatives of Eastern and Western religions. In his introductory speech of the conference on 11 September 1893, he eloquently stated that, 'no religion was superior or inferior to the other'. On 26 September a lecture on "Buddhism, the Fulfillment of Hinduism", Swami Vivekananda highlighted the fact that the Buddha is worshipped as one of the incarnations of God. Incorporating China, Japan and Ceylon (Sri Lanka), where Buddhism is a predominant religious practice, Vivekananda emphasised that Buddha's teachings were a "Gift to the World" and it could be traced to Christianity. He stated that the two religious practices — Hinduism, (a Vedic religion), and Buddhism (of the Shakyamuni), are mutually inclusive. The teachings of Buddha are inherently were rooted in Vedic scriptures. However, one distinction he pointed out that, a comparison with other religions of the world such as Christianity in which Jews who opposed Jesus Christ crucified him. While in India in contrast, Buddha was worshipped

as God. Vivekananda also stated that Buddhism should not be confused with Vedanta; in the same way as the Salvation Army is not to be confused with Christianity. Vivekananda also opined that, Buddhism was the "fulfillment of Hinduism" and thus Buddhists were wedded to the "brains and philosophy of the Brahmins" and similarly the Buddhists were the heart of the Hinduism.

In the context of this, the main focus of the conference is on India's socio cultural, economic and political impact on Southeast Asia. Here Buddhism and the philosophy of Swami Vivekananda play a vital role. Hinduism and Buddhism both spread to these states from India and for many centuries existed there with mutual toleration.

The conference is being organized to encourage interdisciplinary approach along with philosophical viewpoint for better understanding of the influence of Swami Vivekananda and Gautam Buddha in Culture and Civilization of Southeast Asia. This study will enhance cooperation in the field of research and culture between India and its neighboring countries of Southeast Asia considering the impact of Swami Vivekananda and Gautam Buddha in future.
