The Council resolved that the proposal may be approved in principle with financial assistance of Rs. 1.5 lakhs and the organizers may be requested to forward the proposal through proper channel i.e. the Head/ Dean/ Registrar of Jadavpur University.

**Agenda Item No. 7:** To consider the proposal submitted by International Relations Scholastic Conclave (IRSC) to collaborate and organize their 5<sup>th</sup> edition of IRSC on India's Foreign Policy during October, 2015 with request of financial assistance. Budget is Rs. 3 lakhs. (Annexure VII)
